

1. Agenda

3. Minutes of previous Meetings and status of actions

The minutes of the NOOS business meeting 2015 were approved and the progress of the actions listed at this meeting was reviewed.

During the review, it has been mentioned that too many actions were actually not actions because their expected results were not specific enough to be measurable or because no clear action owner has been appointed or finally because the expected completion date was missing. In particular it is decided that actions allocated to "ALL" are no more suitable. Instead, it is decided that actions to "ALL" should be allocated to the steering group that will have the mission to chase for the completion of the action by a clear deadline. The steering group members must then organise themselves and maybe prioritize the actions in order to reach an acceptable and realistic workload balance.

The list of actions for 2015 is therefore presented in the hereunder table with the associated colour code:

- In blue: actions as reported in the NOOS business meeting minutes 2015
- In red: updates and comments on the actions and decisions
- In green: a new action decided at the business meeting 2016 as a follow-up of the action listed just above.

The possible status are "open" (=action decided with a clear owner and a planned completion date), "on-going" (= some progress has been made but the final results is not available yet), "close" (= action competed and results is available), "on hold" (= action blocked for a given reason).

5. Discussion and decision on new NOOS-services, projects and initiatives

NOOS strategic document

Like most of the other ROOSes, NOOS is at a crossroad of its evolution. Indeed, if many concrete and valuable results have been achieved over the last 15 years, the assembly feels that it is time to define new goals and perspectives in order to prevent NOOS to collapse (e.g. the slow but sure

erosion of the number of active members). To this perspective the assembly tasks the steering group and the project leaders to prepare a new NOOS strategic document presenting

- NOOS vision,
- NOOS missions,
- NOOS strategic goals,
- NOOS operational objectives
- NOOS operational plan

The assembly expects a draft document to be ready by the summer break 2017 so that it can be reviewed and amended by the annual meeting 2017. The final plan must be adopted at the annual meeting 2017 at the latest.

Data policy

Following EuroGOOS ambition to be as free and as open as possible, NOOS would like to be able to deliver in Situ Data (and maybe other data and products) to 3rd party (including private companies) without any registration. However, several questions need to be carefully addressed and their answers should be duly documented in a NOOS data policy document.

For instance:

- NOOS MoU specifies the IP for data distribution within the NOOS group. However, the MoU
 does not tell a word about the distribution outside of the group. Does such redistribution
 require the formal agreement of the originating Member?
- What about data coming from non-NOOS member?
- What about the data pumped from the NOOS data portal by CMEMS and/or Emodnetphysics?
- What about the data pumped from CMEMS by the NOOS data portal? Can we deliver CMEMS data without registration?
- Which added value could NOOS data portal deliver with respect to CMEMS or Emodnetphysics? More data? More timely? More variables (e.g. river runoff)?
- Can we add in the metadata a reference to an open license? If so, which license?
- Must NOOS data policy be INSPIRE-compliant?
- ...

Most of these questions have no simple answer. The development of the data policy is therefore an important item to be inserted in the NOOS strategic document. To that respect, the NOOS steering group is tasked to make recommendations for the development and the implementation of the NOOS data policy. Susanne Tamm will support the SG by recommendations for an easy access to observation data via the NOOS portal.

NOOS observation working group

During the annual meeting, the need for a NOOS observation working group focussing on the prospection and definition of user requirements from the NOOS community to access new kind of data has been expressed. For instance, the need for having access to suitable data sets to study the small scale interactions between the atmospheric turbulent boundary layer, waves and the oceanic mixed layer.

The outcome of this working group could then be used at the national level to trigger investment in observation means and technologies.

If there is a general interest of the assembly, no working group leader has been identified and it is decided that the creation of such a working group should be an item of the NOOS strategic document. (task for SG)

In the meanwhile, Stephan Dick will ask Kai Herklotz and Susanne Tamm if they are interested to participate to that group.

7. Collaboration ROOSes/EuroGOOS

Since May 2016, Henning is an executive director of euroGOOS AISBL. Collaboration with EuroGOOS should therefore be easier.

For the first time in 2016, EuroGOOS has organised a meeting with the chairs of the ROOSes and the other EuroGOOS sub bodies. The objectives is reporting past experiences but also fostering collaborations by sharing developments and decisions. The next meeting will be organised back-to-back the next EuroGOOS general assembly meeting 2017.

John Siddorn should contact other ROOSES for interest in the model verification WG.

8. Memberships

As for the last years, the French members were absent. To give us a chance to attract them again, NOOS should systematically extent its activities on the whole European continental North West Shelf including the English Channel and the Irish Sea. This must be a point of concern for the NOOS strategic document.

The assembly deplores the fact that NERSC, Univ. Oldenburg and ACRI are particularly inactive NOOS members. They are not involved in any working groups and projects so that NOOS won't miss their expertise in case of withdrawal. They will be invited to take part to the NOOS activities or ask to present their withdrawal by the next annual meeting. (Stephan Dick will contact Univ. of Oldenburg).

John Siddorn thinks that Jason Holt could be an active NERC delegate to NOOS.

John Siddorn informed us that CEFAS can hardly attend NOOS annual meeting this year but he will check what is possible in terms of waves data...

NIVA has not attended the last 2 annual meeting. Maybe this is due to the fact that NIVA perceives NOOS activities as more model oriented (they are more observation oriented). This is a concern that should be clarified in the NOOS strategy document. Henning is asked to continue inviting them to take part to NOOS activities.

John Siddorn suggests that 'Plymouth Marine Laboratory' might be a nice NOOS member. The assembly agrees with that suggestions and tasks John Siddorn to invite them to present their candidature at the Annual Meeting 2017. This means that PML will present their activities during the annual meeting and the assembly will unanimously decide if they accept or reject their membership during the business review.

Marc Philippart informs us that OPW from Ireland (http://www.opw.ie/en/) might be a good candidate for NOOS partners. However, before inviting them, the marine institute should give their formal approbation.

The co-chairs are tasked to come with a realistic agenda proposal by end Jan 2017. In particular, it is asked to better manage the oral presentations of the member reports. The assembly agrees that max 4 members announced in advance could present all their activities (in a ~15' talk). Assuming the written member reports will be available at least 2 weeks before the annual meeting, the other members will have ~5 minutes to present a specific development with scientific and/or innovative content. A simple reading of the member reports or an improvised presentation won't be allowed anymore.

Introduction

On behalf of the NOOS general assembly, John Siddorn acknowledged Bruce Hackett and Stephan Dick for their extremely valuable contribution to NOOS. The steering group will miss Bruce's and Stephan's long experience and expertise.

Organisation of the steering group work

With the establishment of the co-chairs, the organisation of the steering group must be updated. Pending Henning's approbation, it is suggested that

- 1. As soon as available, the minutes of the NOOS annual meeting are sent to the general assembly and uploaded to the NOOS website. The minutes must at least include the list of decisions and actions agreed during the business meeting.
- 2. Whenever necessary and with a minimal quarterly frequency, co-chairs must have a phone conference to update each other of the past and future developments, events, meetings, tasks, actions and deadlines. The objective is to share the workload in an efficient way. If useful, a report can be send to steering group and/or the NOOS members.
- 3. One month ahead a steering group meeting, co-chairs send an email inviting the NOOS project and WG leaders to give update on the past and future developments, events, meetings, tasks, actions and deadlines associated to their work plan. The objective is to have two "rush period" a year.
- 4. Whenever necessary and with a minimal half-yearly frequency, the steering group meets to discuss the past and future developments, events, meetings, tasks, actions and deadlines. A special attention is paid on the follow-up of the actions decided during the annual meeting and on the organisation the next annual meeting. A report should be sent to the NOOS members.
- 5. Two months ahead an annual meeting, the invitation to the annual meeting is sent to the NOOS members. Should be available:
 - the agenda,
 - the list of hotels,
 - the minutes of the previous annual meeting,
 - if available the minutes of the previous steering group meeting,
 - a reminder for the member reports (to be available 2 weeks before the meeting),
 - a reminder to the project leader for their project factsheet (to be available 2 weeks before the meeting).

- 6. The member reports and project factsheets must be uploaded on NOOS website 2 weeks before the annual meeting. Steering group members must chase for missing reports.
- 7. Just after the annual meeting, the brief steering group meeting to debrief on the previous annual meeting and to (try to) review the list of decisions and share the workload.
- 8. The week after the meeting, all the presentation should have been uploaded on the website, on the annual meeting page.

NOOS strategic document

This action is the top priority for the first semester 2017. It is agreed that the co-chairs must draft the documents on basis of regular feedbacks from steering group members and NOOS project leaders. This task should be kicked off by mid January 2017, where the co-chair must sent a schedule and template of the strategic vision.
